ORDINANCE NO. 21-19 – BOND ORDINANCE SUPPLEMENTING SECTION 3(b) OF BOND ORDINANCE NO. 21-03 FINALLY ADOPTED ON FEBRUARY 23, 2021 PROVIDING FOR THE 2021 ROAD IMPROVEMENT PROJECT - PHASE I BY THE BOROUGH OF TENAFLY, BY APPROPRIATING AN ADDITIONAL \$50,000 THEREFOR AND BY AUTHORIZING THE ISSUANCE OF AN ADDITIONAL \$47,600 BONDS OR NOTES OF THE BOROUGH TO FINANCE THE COST THEREOF

ORDINANCE NO. 21-20 – BOND ORDINANCE PROVIDING FOR THE TROPICAL STORM IDA ROAD IMPROVEMENT PROJECT BY THE BOROUGH OF TENAFLY, APPROPRIATING \$3,500,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$3,333,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF
