TO BE CONSIDERED

NJ Historic Trust (NJHT) - Capital Preservation Grants Program

Mr. Homsi explained that through the grants portal that he provided grants relevant to the Historic Preservation Commission. He added that the Inness Gates repair would be difficult to fund through the grant program. C. Grossman added that the state or the federal government has not designated Inness Gates as historical but the county has. C. Dayton asked if this grant could considered for a Women's Suffrage Museum. C. Grossman expressed that it has been discussed but a location of the museum needs to bed decided. J. Homsi expressed that a fire suppression system could be considered for a grant opportunity at the Elizabeth Cady Stanton Train Station. M. Zinna asked what is next. Mr. Homsi explained that it would be beneficial to the HPC as the fire suppression system would create efficiencies in the building for a reasonable cost. Mr. Homsi explained that the project is eligible for a grant though the State or the County's Open Space trust grant. J. Homsi added the historic preservation plan is \$20,000. M. Zinna asked what is favorable applying to the County or State grant program. J. Homsi responded that applying for the County's grant program would be most favorable. C. O' Connor expressed that she remembers that Borough Engineer Andy Hipolit explained that only one program could be applied for through the Open Space Element. C. Grossman suggested to fund the historic preservation plan through the Borough's Open Space. Mr. Homsi noted that the historic preservation plan would be funded in 2023 through the Borough's Open Space.

Memorial Day Banner

Mr. Homsi explained that C. O' Connor suggested a banner to be used at Borough events. C. Michaels suggested that Giovatto Advertising could provide a mock –up for a banner. C. Michaels expressed that he'll contact Giovatto regarding the banner design.

Solid Waste Contract

Mr. Homsi explained to the Governing Body that the current Solid Waste Contract is set to expire in April 2024. Mr. Homsi presented a redline of specifications to the Government Body to review before getting authorization to go out to bid. Mr. Homsi added that the options are the same from the previous specifications. M. Zinna expressed that bids could be rejected by the Governing Body if its choose. Borough Attorney Wendy Rubinstein Quiroga explained that it could be rejected within the statues, especially if it exceeds the budgeted amount. C. Menon asked if there is a budget impact. Chief Financial Officer Susan Corrado expressed that she is concerned about the rejection of the bid

since there is no budget. Ms. Rubinstein Quiroga responded that estimates could be determined from appropriations from prior years. The Governing Body will agreed that in the resolution for authorization to bid that language concerning vegetative materials be added.

Potential Grants for Open Space Trust Fund Programs

- C. Michaels expressed that the multi cage option would allow for a larger grant award. C. Park expressed that he is looking to expand the project. C. Dayton added that combining two items for one contiguous project would make sense and that she loved the idea. C. Menon expressed that he would like a master plan without executables. The Governing Body expressed that it would like to proceed with three items: master plan, planner, multi-use cage for the Open Space Trust Fund.
- C. Dayton asked for Walnut Park be considered for Open Space. M. Zinna directed that the Walnut Park discussion be added on the April 18th meeting.

Roosevelt Pond Landscaping

C. Dayton expressed that she discussed with Mike Cassidy about the beautification of the pond. C. Grossman expressed that willows were once in the area, which was attracting geese.

ADMINISTRATOR REPORT

- Mr. Homsi asked the Governing Body if they had any questions concerning his report.
- C. Dayton expressed that the Borough look into at a grant for stormwater assistance. Mr. Homsi explained that he is working with Mr. Hipolit in planning for grant.
- M. Zinna expressed that the Bliss Avenue Bridge is opening is coming shortly with a ribbon cutting ceremony to come.
